Updates from Jen Crawford presented by Albino

Our grant contract has passed both the program and fiscal review but we still don't have authorization from the Department of the Budget to execute it. Once we do we will have the opportunity to review it with our lawyer before the contract is finalized.

We should include in our thoughts how we might be able to mitigate the issue of sea rise and its effects on Germantown, working with Amtrak for instance and neighboring communities.

Since Crawford will not be able to lead or attend meetings through November due to fire department training, perhaps we should discuss our plan to move forward

NEW BUSINESS

Discussion of the death of the woman on the tracks north of us and its impact on our waterfront program. Kaare Christian placed our efforts on keeping the waterfront open to people. Amtrak should be concerned with keeping people from the tracks, not the water. Perhaps signs in the kiosks on safety and the train speed.

Albino will continue to look at the any town's (large, small any) LWRP's to see what consultants were used and for what and see how they approached issues similar to ours.

VISION

We need to have own vision — perhaps we should make our own document explaining our ideas to ourselves.

What do we want to do and when — a timeline

We have to figure out how we want to interpret the state coastal policies and how they apply to Germantown. NY has some 55 coastal policies. Will help with our talking to Amtrak. Shoreline project developers must file a federal consistency assessment form with DOS, a document that details how their plan aligns with those rules.

Our consultant and our community should be partners in developing this vision.

We want to tie our hamlet to our waterfront.

The land included in the LWRP does include private properties and we should consider if there are impacts on these private properties.

CONSULTANTS

Jeff from Scenic Hudson has a list of consultants — list is on our google drive.

Albino said some towns had one consultant and others had more than one. It would be great to have one, but there was no evaluation of which worked better
