Old Business

- Kellner Activity building- One party attended the Pre-bid meeting, no bids have been received. How to proceed? Corinne said to go back out to bid. Corinne also said to be careful about not putting competitive bidding. Supervisor Helsley said that Corinne will put together a package and will go back out to bid. Brandon suggested that Delaware Engineering put the bid on their website.
- STR Law- Resolution to approve. Councilman Sullivan said the board received input from Brandon and invited him to the meeting tonight. Brandon said most of this law doesn't make sense. Brandon said the law is allowing these portable stay units on vacant pieces of land. Corinne said the town board took out some of the requirements to make it less lengthy. Supervisor Helsley asked Brandon about enforceability and Brandon said it would be tough. Supervisor Helsley doesn't like writing a law that can't be enforced. Councilmember Suarez said that people operating STR are more responsive to local laws and government. Councilmember Suarez said she is not in favor of dropping the law after 4 years of hard work. Corinne can work with Brandon about his concerns on this law on the enforceabiltily. Supervisor Helsley said they are not prepared to make this decision. Motion to approve the STR Law as written made by Councilmember Suarez, seconded by Councilman Christian.

- SPEDES Permit- sample results have been received- DE continuing to prepare documents and maps.
- DEC is questioning the efficacy of the pre-screen, Supervisor Helsley has asked for information to contact the supplier for a visit to confirm proper operation and/or selection.
- DEC has proposed an April 30 deadline for submission of application, DE has agreed that we will meet the deadline.
- Solar Law- recommendations for changes or leave the current law as it is?
- Bard Parcel- revised budget- next steps? Councilman Christian got the revised budget in. Councilman Christian said on April 26th there will be a site visit with Scenic Hudson and Columbia County Land Conservancy. The Town Board approved a minor budget adjustment allowing Anthony to rent a skid steer with forestry attachment for trail clearing. Councilman Christian also said Anthony recommended creating a new parking lot to enable public access using town land on the south side of Maple Avenue halfway between the Parsonage and Maple Avenue Extension where there is high ground and an already compacted farm road.

New Business

- Approval to purchase a new walk in cooler- Supervisor Helsley said there are 2 old coolers that were removed by DPW. Supervisor Helsley said there are 4 written quotes, the lowest quote is \$16,900. Town Board made the decision to pass on the walk in cooler at this time.
- Motion to accept a \$5,000 grant from the New World Foundation for a municipal building energy audit. Supervisor Helsley read the following Resolution:

Comments from Councilmembers

Councilman Kukon thanked the STR committee for all the time they put into the law.

Councilman Christian said CSC 2025-2026 fiscal year clean energy program work with smaller communities.

Councilman Christian said Supervisor Helsley will sign the letter and he will send it to NYSERDA. Councilman Christian also said the revised budget if the Town Board agrees with the changes. Corinne said they don't have the final contract. Councilman Christian said they will get the budget and ask about the contract.

Comments and Questions from the public

Dale said the flagpole at Lasher Park broke in half and he said they had no luck finding the warranty. Dale said Tim Otty got 3 quotes: fiberglass pole \$2,000, Aluminum pole \$2,456.98 and Hurricane Resistant pole \$4,066.98. Dale said the American Legion would be willing to help with some of the cost. Supervisor Helsley will review and see if they are warranteed and then talk with Dale.

Martin Overington mentioned River Sweep on May 4th. Martin said that WAC got the grant from the Bank of Greene County. \$750 for weed cutting. Martin also said on lower Main Street there was flooding because of a clogged storm drain and the sewer back up as well. Supervisor Helsley said they received a high level alarm. Martin said not until they called. Supervisor Helsley will follow up with Joe and make Delaware Engineering aware of this.

Brandon had a suggestion that the flagpole design hold up to at least 115mph winds.

Kerrie Abela said her building is closed and she is asking to lower her sewer bill? Supervisor Helsley said her fee will be adjusted. Supervisor Helsley thanked Kerrie for her years in business.

Tom Shannon said there was wind damage at the Parsonage. Tom and Ethan suggested possibly doing asphalt shingles that look like wood. Tom said that Friends of Historic Germantown are going to try to raise some money for the roof. Tom also mentioned the

chimney needs to be repointed. Tom mentioned National Marker Day. Tom said they are going to clean up the Vietnam monument and that last year they cleaned up the WWII monument.
